Subject 2:

Resolution

The subject was considered and unanimously resolved to approve the revision of the ratio between the Internal and External marks for all the PG programmes from 25:75 to 40:60 from the academic year 2019-2020.

Subject 3:

Approval for the award of extra credits to students who complete successfully an NPTEL course.

Resolution

The subject was considered and resolved to award extra credits of 2, 4 and 6 to the students who successfully complete NPTEL course with the duration of 4, 8 and 12 weeks respectively.

Subject 4:

Approval for the introduction of Internship as optional for the PG students at the end of the second semester.

Resolution

Dr. H. Shakila and Dr. M. Ramakrishnan University Nominees suggested that granting 5 credits for an internship for a period of thirty days may be too much and so recommended to award 3 credits for the internship of thirty working days. Hence, it was resolved to introduce internship as an optional one for the PG students at the end of the second semester and to award an extra credit of 3 to the students who complete the Internship for a minimum period of thirty working days.

Subject 5:

Approval for the introduction of UGC funded B.Voc. Programme on *Food Safety* and Quality Management.

Resolution

The Council congratulated the initiatives of the college to start a B.Voc. Programme on *Food Safety and Quality Management* and was pleased to give its approval for the introduction of the programme from the academic year 2019-2020.

Subject 6:

Approval for the introduction of Gandhian Thought as an optional Self-Learning Course in the academic year 2019-2020.

Resolution

The subject was considered and resolved to approve the introduction of *Gandhian Thought* as an optional Self-Learning Subject in the fourth semester of all UG programmes from the academic year 2019-2020 and to award an extra credit of 5 to students who complete the course successfully.

Subject 7:

Approval for making Plagiarism check mandatory for submission of M.Phil. dissertation.

Resolution

The subject was considered and resolved to make plagiarism check mandatory for submission of M.Phil. dissertation with effect from 1st April, 2019.

Dr. M. Ramakrishnan, the University Nominee suggested that in order to gain more knowledge more number reference books with the latest editions might be given while finalizing syllabus for a course.

All the seven resolutions were unanimously passed.

Out of 36 members, 30 turned out for the meeting and 6 members got permission to absent.
